## Estimated delivery date: w/c 19 April 2022


There will be changes to your roles in NIVS. As a NIVS user, you will see reports assigned to your role that are unique to your role in the system.

## A @nhs.net email required by ALL Superusers

# Estimated delivery date: 02 May 2022

To meet a Vaccination Programme requirement, from 2<sup>nd</sup> May 2022 all Superusers requiring access to NIVS <u>must</u> have a @nhs.net account.

From this date any Superuser with any email other than this standard will have their account changed from Superusers to a Vaccinator. This will not prevent the administering of vaccines - however you will no longer be able to manage other system users.

Over the coming week, we will be contacting each Superuser that has a different email address directly to assist them with the changeover.

@nhs.co.uk or .gov.uk will no longer be acceptable for the Superuser role.

# Seven Day Limitation on Vaccination entry Estimated delivery date: w/c 10 May 2022

To meet a Vaccination Programme requirement, from 10th May 2022 there will be a restriction placed on the date that you will be able to input a Covid vaccination into NIVS.

This will mean that from this date, you will not be able to enter a vaccine into the system that was administered more than 7 calendar days ago.

Upcoming comms will provide guidance, help and documentation to support you with this change.

## **Vaccine Name Change:**

Estimated delivery date: w/c 10 May 2022

To meet a Vaccination Programme requirement, the current AstraZeneca vaccine will be renamed in NIVS to:

Vaxzevria 0.5ml dose (AstraZeneca)

This will align the current Astrazeneca vaccine naming conventions to match other current Covid vaccines.

e.g. Spikevax 0.1mg/0.5ml dose (Moderna)

Comirnaty 30micrograms/0.3ml dose (Pfizer).






#### **Multi Factor Authentication:**

Estimated delivery date: w/c 10 May 2022

To enhance the security of NIVS, we will be requiring Superusers to identify themselves by more than just a username and password.

This will be in form of a PIN that will need to be entered into the logon screen of NIVS.

Please look out of for upcoming communications from your SPOC that will contain the process to register for MFA and how to use it.
